Youth Athletic Grade/Age Cut-off Policy

At their May 1998 board meeting, Recreation Commissioners approved the following policy for age/grade cut-offs for our youth sports programs. Players must play in their designated age group.

1. Any youth turning five before the start of a program will be eligible to participate in either Pee Wee League or the Kindergarten League even though they may not be in Kindergarten.

2. Baseball/Softball: Participants age on or before September 1, 2010

3. ADA ACCOMODATIONS: A youth with mental or physical disability may request to be held back or placed in a division lower than they typically would play. CRC staff will make approval.

PARENT/S GUARDIAN RELEASE:
